## Medical Advisory Board

### 2025/2026 PROSPECTUS

#### Overview

The Cholangiocarcinoma Foundation (CCF) offers high-impact, 2-hour Medical Advisory Boards (MAB) designed to provide non-binding, expert insights to companies working in the cholangiocarcinoma (CCA) space. These virtual sessions are facilitated through CCF's International Cholangiocarcinoma Research Network (ICRN), a global consortium of over 439 researchers and clinicians from 206 institutions across 34 countries.

The advisory panel is composed of a carefully selected subset of ICRN members, chosen based on the company's specific needs and objectives, such as but not limited to:

- Clinical trial design
- Real-world treatment feedback
- Biomarker strategies
- Regional considerations

#### Format

**Duration:** 2 hours via Zoom

**Participants:** Six ICRN investigators/clinicians, selected based on company needs

**Moderator:** The sessions are confidential and collaborative and typically moderated by Dr. Juan Valle, CCF's Chief Medical Officer and internationally recognized cholangiocarcinoma expert. An alternative moderator may be selected based on the topic, geographic region, or company preference to ensure the most relevant expertise.

**Session Includes:**

- Pre-meeting coordination on goals, agenda, and participant selection
- Recruiting, contracting, and preparing participants
- Company-led presentation (if applicable)
- Prepared discussion questions and open dialogue
- Optional polling and post-meeting surveys

**Timeline:** Planning and execution typically take 6-8 weeks from the pledge being received by CCF.
