The network includes trained experts from various disciplines, perspectives, and research methods who share a passion for making significant scientific advances to improve outcomes for patients with cholangiocarcinoma. The Organization pioneered and maintains a robust program to support innovative scientific discovery through a research fellowship program with annual awards provided to qualified researchers.
