The Organization advances scientific discovery through its Research Fellowship Program, Career Development Award, and Innovation Grants, which collectively support emerging investigators and fund transformative, high-impact studies. It also convened the International Cholangiocarcinoma Consensus Conference, uniting global experts to establish research priorities and accelerate clinical translation. These efforts are anchored in the International Cholangiocarcinoma Research Network (ICRN) - a worldwide collaboration driving progress in etiology, prevention, early detection, and treatment. Through ICRN subcommittees, the Organization leverages shared data and cultivates future leaders in research and care.

The Organization provides support services to individuals diagnosed with cholangiocarcinoma and their caregivers.
